

Terms of Use / Disclaimer

The **Accelerated RIA Investment Access (“ARIA”)** portal provides a central access point for financial professionals affiliated with Registered Investment Advisers (“RIAs”) to evaluate information concerning fixed income investments, structured products and alternative investments. ARIA is comprised of three (3) unaffiliated platforms – BondNav (fixed income investments), sponsored by InspereX Technologies LLC, Luma (structured products), sponsored by Luma Financial Technologies, LLC, and SUBSCRIBE (alternative investments), sponsored by Strategic Alternative Funds Group, LLC.

In order to access the information contained on each of these platforms, you may be required by the sponsor of each platform to enter into an access agreement or other form of use agreement with such sponsor. In connection therewith, you and your firm may be required to provide the sponsor with onboarding and other information to enable such access.
